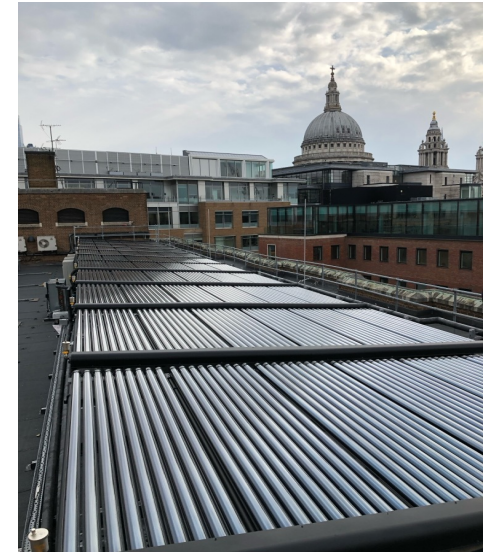

## Central Criminal Court, the Old Bailey – City of London

Solar UK was appointed by Tilbury Douglas Engineering to design, supply, and install a new rooftop solar thermal solution for their client, the City of London Corporation, at this historic city centre site.

As part of a 10-year plant replacement programme, which included extensive site-decarbonisation objectives, the building's DHW supply has now moved from gas to solar thermal.

Using our market-leading LaZer2 solar thermal collectors, made at our factory in East Sussex, we installed a rooftop collector array, which feeds the three large calorifiers in the basement plantroom.

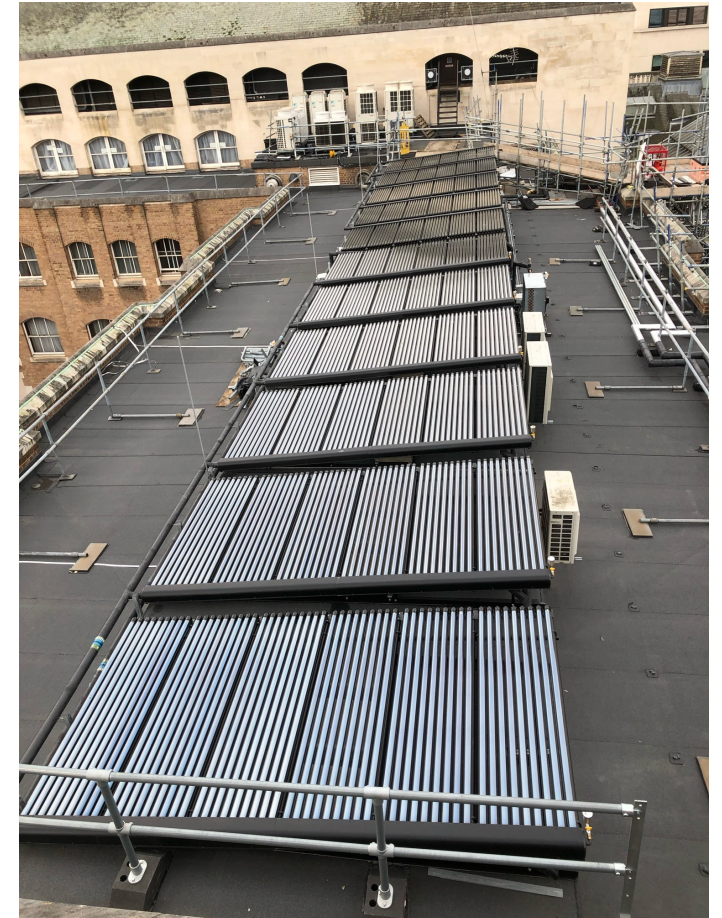
Working closely with the Tilbury Douglas Engineering team, we worked with some site constraints that included restricted noise levels during court hours, no hot works, complex pipe runs through this 100-year-old building, concealed external pipe runs, unforeseen planning delays, and the integration with the building's BMS.
